## Washington Dulles Global Entry (GE) Mobile Enrollment Event

May 22<sup>nd</sup>, 2024, 9 AM – 2 PM

(Washington Dulles Main Terminal Lover Level in the East Ground Transportation Area)
This event is open to Dulles airport employees with a valid MWAA SIDA badge. Valid
MWAA SIDA badge must be presented to CBP for the special event, no exceptions.
Employees may bring up to two family members. Family must be accompanied by the
employee at the time of the interview.

Must be conditionally approved prior to the interview.

#### What is Global Entry?

Global Entry is a U.S. Customs and Border Protection (CBP) program that allows expedited clearance for pre-approved, low-risk travelers upon arrival in the United States.

Though intended for frequent international travelers, there is no minimum number of trips necessary to qualify for the program. Participants may enter the United States by using automated kiosks located at many major airports or the mobile app. Program members may use their benefits in conjunction with personal and/or official travel.

## **How Does the Global Entry Program Work?**

At airports, program participants proceed to Global Entry kiosks and have a photo taken or you can use the Global Entry mobile app. After using the kiosk or app you will be directed to designated Global Entry lines to speak with an officer. On average, Global Entry members wait less than 10 minutes while using this program upon entering the United States.

## How to Apply and Participate in the Washington Dulles Global Entry Mobile Enrollment Event

Step 1: Apply online via <a href="https://ttp.cbp.dhs.gov">https://ttp.cbp.dhs.gov</a>. Step 2: When the application is complete and you have paid the \$100 fee for a five-year membership validity, you will receive a Membership/ PASSID number, and your application will then go into "pending approval" status.

Step 3: You will receive a confirmation email that will provide additional instructions for participation, including directions for scheduling an appointment for the Mobile Enrollment Event and the access code (L2X769K19) for the TTP online scheduling tool.
